1. 171 Carlynn Drive, Map 138, Parcel 36. Petition of Erin E. Petterson for a variance of the Zoning Regulations; Section 5.2.4 to reduce the rear setback from 30 feet, currently 18.1 feet, proposing 9.1 feet and Section 5.2.4.3 to reduce the street line setback for an accessory structure from 30 feet, proposing 10 feet and Section 5.2.5 to increase lot coverage from 20%, currently 25.3%, proposing 27.8%. Permission to construct a rear deck and platform for a stand-alone generator and an in ground pool. Premises: A Zone

2. 716 Riverside Drive, Map 139, Parcel 276. Petition of Kardamis Construction for a variance of the Zoning Regulations; Section 5.2.4 to reduce the street line, side line and sum of two side line setbacks from 30 feet, 7 feet and 25 feet, currently 22 feet, 6.4 feet and 24.5 feet, proposing 22 feet, 6.4 feet and 24.5 feet and 5.2.5 to increase the lot coverage and total floor area from 20% and 40%, currently 32.41% and 26.9%, proposing 32.41% and 48.14%. Permission to remove existing dwelling to foundation, and construct a new FEMA compliant 2 ½ story single-family dwelling. Premises: A Zone

3. 113 Rowland Road, Map 182, Parcel 169. Petition of Stuart and Polly Tilghman for a variance of the Zoning Regulations; Section 5.2.5 to increase lot coverage from 20%, currently 19.14%, proposing 20.7%. Permission to remove existing garage and rebuild a new one-story two-car garage. Premises: A Zone
